IT IS THE JUDGMENT OF THE COURT THAT THE DEFENDANT IS GUILTY OF:

Molestation of a Child a Class 3 Felony & a Dangerous  
Instrument

It is ordered suspending imposition of sentence and placing defendant on probation under supervision of the Mohave Probation Department (APD) for a period of 12  year(s)  month(s) from this date: 10/3/03 under the following conditions.

THE DEFENDANT SHALL: (Conditions Checked Also Apply)

- 1. Obey all laws.
- 2. Not knowingly associate with any person engaged in criminal activity or having a criminal record without the prior written approval of the APD.
- 3. Report as directed by the APD.
- 4. Let the APD know where you live and provide safe access. Where you live must be approved by the APD and do not move without permission of the APD.
- 5. Submit to search and seizure of your person or property by the APD without a search warrant.
- 6. Not possess or control any firearms, ammunition or deadly weapons as defined in A.R.S. § 13-3701.
- 7. Not possess or use illegal drugs, toxic vapors, prescription drugs without a valid prescription, or any controlled substances.
- 8. Not drink any alcoholic beverage to excess.
- 9. Submit to drug and alcohol testing, as directed by APD.
- 10. Participate and cooperate in any program of counseling or assistance as directed by APD.
- 11. Seek, obtain and maintain employment and / or attend school as directed by APD and advise of any change.
- 12. Not leave the state without written permission of the APD.
- 13. Waive extradition for any probation revocation proceedings in this matter, pursuant to A.R.S. § 13-901.
- 14. Provide a sample for DNA testing as defined by law.
- 15. Abide by and comply with any written directive of the APD to enforce compliance with the conditions of probation.
- 16. Not drink <sup>or possess</sup> any alcoholic beverage.
- 17. Not have any contact with the victim(s) whatsoever, unless approved in writing by the APD.
- 18. Complete 240 hours of approved community work service at a minimum rate of 20 hours per month beginning at sentencing or as otherwise directed in writing by the APD.
- 19. Apply for interstate Compact supervision in the state of \_\_\_\_\_ and, if accepted, abide by all rules and regulations of the program. Do not proceed to any state prior to acceptance unless a resident of that state, or reporting instructions are received from that state.
- 20. Not remain in or return to the United States illegally, if deported or processed through voluntary departure. All conditions except for #1 are suspended while outside the United States.
- 21. Be incarcerated in the county jail for 120 3 days  months, beginning 10/29/03 with credit for 0 days served. Upon screening and acceptance, abide by all conditional release program rules. Report to the APD within 72 hours of release.
- 22. Be committed to the Arizona Department of Corrections for  months  years, with credit for      days served. Report to the APD within 72 hours of release.
- 23. Abide by the Judgment and Orders of Restitution, Fines and Fees in this case.
- 24. Register as a Sex Offender as defined by law.
- 25. Abide by the attached special conditions of probation
- 26. Abide by the Sex Offender Mgt
